### Updated Travel Advisory:

Licking/Knox Goodwill Industries Inc. requests all employees who take vacation during the COVID-19 pandemic share their travel plans. Supervisors should be notified of your itinerary prior to traveling. Employees who travel to a state listed on the Ohio Department of Health Travel Warning Advisory will be required to complete a quarantine option prior to returning to work.

**Option 1:** Have a negative COVID-19 test and quarantine for seven (7) days.

**Option 2:** Quarantine for 14 days.

If an employee's results are not released prior to the seventh (7th) day of quarantine, the employee will be asked to continue to quarantine until their results are known. It will be the employee's responsibility to keep their supervisor informed about the progress of their results.

If an employee's results report positive, the employee will be required to meet all local health department requirements prior to being allowed to return to work.

Anyone visiting or hosting visitors from the following states August 19 – August 26, 2020 will need to observe the quarantine options listed above.

- Florida
- Idaho
- Mississippi
- Nevada

Anyone visiting or hosting visitors from the following states August 12 – August 19, 2020 will need to observe the quarantine options listed above.

- Alabama
- Florida
- Idaho
- Mississippi
- Nevada
- Texas

Anyone visiting or hosting visitors from the following states August 5 – August 12, 2020 will need to observe the quarantine options listed above.

- Alabama
- Arizona
- Florida

Licking/Knox Goodwill Industries Inc. requests all employees hosting guests during the COVID-19 pandemic share their plans.
